Criminal: Post-sentence motion; murder case; subject matter for expert testimony; use of term “execution style shooting”; oratorical flair in prosecutor’s argument; coordinate jurisdiction rule; preclusion of expert testimony on effect of intoxication on defendant; harmless error; mistrial motion; Commonwealth medical witness called on to provide medical care to juror; cautionary instruction; expert testimony that knife is offensive weapon; admissibility of evidence of victim’s companion’s criminal record; relevance and remoteness; defendant opening the door to admissibility of precluded evidence; discretion of the court in admitting some but not all photographs of defendant’s injuries; preclusion of evidence of defendant’s “possible concussion”; requisite standard of certainty for expert testimony; evidence required for voluntary manslaughter and heat of passion instructions; sufficiency of evidence; self defense evidence; weight of the evidence; claimed excessive sentence. Civil, Criminal: Commonwealth motion to reconsider sentence; credit for presentencing incarceration against more than one sentence for the same time served; factors to be considered in sentencing; effect of incarceration on defendant’s psychological conditions; appropriate sentence where incarceration is causing behavior of defendant to deteriorate. Criminal: Post-sentence motion for judgment of acquittal and for new trial; robbery and burglary offenses; sufficiency of identification evidence. (Frederick060914L)

Criminal: Motion to suppress; DUI; motor vehicle stop; probable cause; multiple violations of the motor vehicle code. (harris060214L)

Criminal: Non-jury trial; DUI; sufficiency of evidence of vehicle operation; chemical testing timing; good cause as to why blood test sample could not be obtained within two hours; delay caused by defendant’s extreme intoxication. (Grimes060514L)

► **Giles vs. Read** (06/04/2014)—Judge Richard A. Gray

Civil: Petition to file a motion for post-trial relief nunc pro tunc; direct appeal of non-jury verdict dismissed for failure to file post-trial motions; extraordinary circumstances interfering with the timely filing of motion; several day delay between when prothonotary filed verdict and when it was mailed, claimed to have resulted in 3-month delay in filing post-trial motions; equities considered. (Giles060414g)

Wills and Estates: Objections to first and final account; extended delay in settling estate; executor's duty to the estate; disputes among family members and litigation; reasonableness of attorney and executor fees; reasonableness of executor's expenses; surcharge requests related to sales of real estate and condemnation settlement; dispute as to retention or distribution of real estate asset.
