Criminal: Appeal; voluntary or understanding nature of guilty plea of person subsequently claiming to have been intoxicated during the hearing; waiver by failing to raise issue during hearing; manifest injustice; voluntariness demonstrated by testimony at hearing. (Geist112917L)
- ▶ **WS vs. CH** (11/28/2017)—Judge Nancy L. Butts
Criminal, Family: Appeal; indirect criminal contempt for a violation of PFA order; access to weapon in pole-barn on property of grandmother-in-law; sufficiency of evidence. (WS112817bt)
- ▶ **In the Interest of JSZ** (11/22/2017)—Judge Joy Reynolds McCoy
Criminal: Commonwealth appeal; waiver of issues by failure to file concise statement of matters complained of on appeal. (InRe-JSZ112217m)
- ▶ **Commonwealth vs. Aungst** (11/27/2017)—Judge Marc F. Lovecchio
Criminal: Appeal; Post Conviction Relief Act petition denial; claimed manifestly excessive sentence; responsibility of counsel of candor to the appellate tribunal; resentencing for repeated violations of probation including continued use of heroin over 16 months in spite of multiple treatment efforts and an overdose and then absconding completely from supervision. (aunkst112717L)

Criminal: Post-sentence motion for judgment of acquittal; ineffective trial counsel; discretion to address claim of ineffectiveness in post-trial stage; corpus delicti rule; waiver by failure to object; viability of conviction where there is no eyewitness to an assault; crimes proven by wholly circumstantial evidence; motion for new trial due to new evidence; sentencing discretion; sentence within standard range of guidelines; addressing the relevant sentencing factors (hunter112217L)
- ▶ **Winner & Schramm vs. Armstrong Township** (11/20/2017)—Judge Dudley N. Anderson
Civil: Preliminary objections; declaratory judgment regarding enforceability of subdivision approval condition; relief available for any proceeding within the exclusive jurisdiction of a tribunal other than a court; advisory opinion. (Winner112017a)
